- 2. The exhibit area will be open as follows: Monday, October 6

  Wednesday, October 8
  10:15 a.m. 4:15 p.m.
  The executive conference committee has the right to amend these times if necessary.
- Conference attendees will be free to participate in the exhibit area before and after sessions, during coffee breaks and luncheons.
- 4. Only authorized conference participants, authors and exhibitors will be admitted at the conference. The name of the authorized representatives shall be furnished to the exhibit manager not less than ten (10) days before the opening of the conference.
